Entry Fee is \$10 and we must have at least 15 entries to have this category.

Total Prize Money will total \$4910.

- The Grand Champion will receive \$1500.
- Reserve Grand Champion will receive \$750.
- Third Place Prize will receive a complimentary registration for the 2013 contest.
- First Place in each category will receive \$350 and prize money will be awarded through 10th place.
